This document serves to officially confirm the **Myers Automotive Group** has agreed to sponsor your team and thereby grant you the use of the name **Myers Snipers** for your team for this upcoming Spring Hockey Season.

Thank you for making the time and effort to help these young players to grow their love of hockey, develop their skills and confidence, and learn life lessons through sport. It's a big commitment to volunteer your time and we congratulate you for doing so.

**A. As part of this sponsorship, Myers Automotive's commitment to you will be:**

- 1. Myers Snipers AAA Hockey Sponsored Website*** – Myers is providing your team website, hosted by TeamSnap, at no cost to you. In turn, you agree to use the TeamSnap Myers Snipers AAA Hockey Sponsored team site exclusively. You are required to populate this site frequently with scheduled practices, games, results and any news of interest, as well as invite your team members to join. Your players and their families will look forward to reading the latest news and results from your team and other Myers Snipers teams.
- 2. Team Insurance*** – Myers will arrange and pay for all teams' insurance. Team insurance must be in place before any team activity takes place.
- 3. Team Jerseys and Pant Shells*** – Myers will provide your team with a set of home and away jerseys in good condition, pant shells and matching new hockey socks. The jerseys and pant shells remain the property of Myers and must be returned in good condition. These items must be returned to Myers upon completion of the season. A **\$500 REFUNDABLE DEPOSIT** will be required before you receive your team jerseys.

Teams are required to stitch player name bars on the back at the top of each jersey, but these must be removed before returning them at the end of the season. No other signage, banners or sponsorships are permitted on any of the jerseys.

- 4. Team Track Suits and Ball Caps*** – A budget of up to \$160 per player AND 3 to 4 Coaches will be provided for Myers Sniper track suits and Sniper Baseball Caps, which will be theirs to keep! Myers will require a "proof" of the Track Suit, Baseball Cap and use of the logo before placing orders. Myers will require a copy of the invoice before reimbursing the cost. No other signage, banners or sponsorships are permitted on the track suits.

**B. As part of this sponsorship, you accept the following responsibilities:**

- 1. Team Name** – You agree to list your team name on all publications and communications as follows: Year, Myers Snipers, Level, AAA. (Example: 2014 Myers Snipers Major Novice AAA).
- 2. Insurance Waiver** - Please ensure each of your players and parents complete and return the **Waiver and Release of Liability Form**. Each player must have their form completed with their Guardian/Parent's consent before being accepted on the team or being allowed to participate in any Myers Sniper sponsored team activities. As best practice, please email the form to the parents, have them scan and email back the filled out form. Once forms are completed and received, email to Loryanne and Jessica at Myers, at [marketing1@myers.ca](mailto:marketing1@myers.ca).
- 3. Police Records Check** – A police records check is required for all Myers Snipers coaches. Please email supporting documents to [marketing1@myers.ca](mailto:marketing1@myers.ca). All files will be held in strict confidence.
- 4. Tournaments** – You agree to enter your team into a **minimum** of four (4) spring hockey tournaments, two (2) of which must be located in the greater Ottawa Region.
- 5. Dress Code and Use of Track Suits** – Players and Coaches must wear their Myers Snipers gear to and from all Team Games and Practices; Coaches must also wear on ice during practice and games.
- 6. Team Jersey and Pant Shell Refundable Deposit** – You agree to provide a \$500 Refundable Deposit before receiving your Team Jerseys and Pant Shells. The deposit will be returned once all Team Jerseys have been returned in good condition. You agree to return all jerseys and pant shells to Myers, 1200 Baseline Road, before June 30<sup>th</sup>. Myers reserves the right to deduct up to \$200 per jersey for damaged or unreturned jerseys.  
  
Organizing and inventorying jerseys at the beginning and end of each year is a large task. Protecting our investment in these jerseys is a priority. Therefore proper storage with us over the summer/winter months is mandatory.
- 7. Team Jersey and Pant Shell Order Form** – Please fill out the ORDER FORM. If we supply existing Team Jerseys and Pant Shells we will fill this form out for you. The form must be completed and signed with a \$500 REFUNDABLE DEPOSIT confirming what was received and what must be returned to Myers at the end of the spring season.
- 8. Option to Purchase Set of Team Jerseys** – Myers encourages and will gladly sell team jerseys (home, away or both) at MYERS COST. Individual or sets of jerseys can be purchased. Please contact Loryanne and Jessica at Myers, [marketing1@myers.ca](mailto:marketing1@myers.ca), to purchase your jersey(s).
- 9. Bank Account** - Open an account under your team name (ie. **Myers Snipers 2006 AAA**). Two team representatives (ie. the Head Coach, Team Manager or Treasurer) should have their names appear on team cheques. We encourage your parents, sponsors, and/or supporters to pay by cheque to assist you with your financial statement. Please inform your bank that the **Myers Automotive Group** reserves the right to get a copy of the monthly statement for audit purposes if discrepancies were to be reported.
- 10. Team Budget** - A preliminary budget should be provided to your parents and coaches before the season and a final financial report at the end of the season. The budget is to inform the parents on your intentions and ideas on how you wish to manage the team revenues and expenses. All fund raisings will be the property of your team.
